# CALL FOR WORKSHOP PROPOSALS

The conference takes place at Rutgers Law School in Newark, NJ, in partnership with the Community and Transactional Lawyering Clinic of Rutgers Law School – Newark.

### **What we are looking for**

Workshops imparting vision, knowledge, and experience with building anti-racist multiracial community. Some examples might be:

- Case studies of building anti-racist multiracial community, within your organization, or in others
- Historical examples of anti-racist multiracial community
- Multiracial organizing for social justice
- Programs of intentional racial integration
- Best practices and lessons learned
- Social policy and legal frameworks in support or opposition to building anti-racist multiracial community
- Social scientific research on building anti-racist multiracial community
- Self-development, skills development, self-care, wellness practices surrounding building anti-racist multiracial community
- Any other topic that will give conference attendees a better understanding of what anti-racist multiracial community looks like, and how to work to support it.

**While antiracism is essential, this call specifically seeks workshops that concentrate on building multiracial communities rather than focusing solely on antiracism. We encourage proposals that highlight how racially diverse individuals and groups can work together, celebrate their differences, and create a cohesive community environment.**

### **Workshop logistics**

- Workshops will be 90 minutes long including time for Q & A with the audience.

## Submission process

Send your proposal (2 pages maximum) to [contact@cswac.org](mailto:contact@cswac.org) no later than **11:59pm Friday, June 14**, with the following information:

- Organization/group/individual name, and website address if available
- Contact person for this workshop, plus email and phone number
- Names of presenter(s), and if part of an organization/group then role(s) with the organization/group
- Title and description of the workshop
- A short statement of how the workshop relates to **both**: 1) anti-racism, and 2) building multiracial community.

We encourage submissions from grassroots organizations/organizers. We seek a broad representation across many sectors including food justice, climate justice, the arts, faith communities, residential integration, school integration, and racial justice.

Please know that we are unable to consider proposals submitted after the June 14<sup>th</sup> deadline.

## Review and notification

We may ask you to provide additional information and/or respond to questions about your proposal, either by email or a brief Zoom meeting.

Proposals will be reviewed for appropriateness of topic, fit with overall conference theme, depth of experience, and information value of contents.

Notice of proposals accepted, or not accepted, will be sent by email by end-of-day Friday, June 28.

## Conference registration

The conference will make available a discounted registration ticket for up to two presenters for a workshop.

All conference presenters must be registered for the conference.
